BOUSTEAD SUBSIDIARY AWARDED S\$70M DESIGN-AND-BUILD CONTRACT FOR DB SCHENKER'S INTEGRATED LOGISTICS FACILITY

- ***Over S\$158 million of industrial real estate contracts secured by division in FY2013; 6th contract secured in past three months***
- ***27th logistics facility undertaken by division, strengthening division's leading status as builder of choice in logistics industry with over 785,000 square metres of GFA in industry-specific experience***
- ***Boustead Group's order book backlog raised to over S\$422 million***

Boustead Singapore Limited ("Boustead") is pleased to announce that its wholly-owned subsidiary, Boustead Projects Pte Ltd ("Boustead Projects") – a leading specialist in industrial real estate solutions – has been awarded a S\$70 million contract to design and build an integrated ramp-up logistics and office facility (the "Facility") for Schenker Singapore (Pte) Ltd ("DB Schenker") to be located at the 24-hectare Tampines LogisPark in Singapore.

DB Schenker Logistics is the logistics business unit of DB Schenker which stands for the transportation and logistics activities of Deutsche Bahn (German Railways). Deutsche Bahn is one of the world's leading mobility and logistics corporations with operations in over 130 countries. DB Schenker Logistics offers land transport, air and ocean freight, comprehensive logistics solutions and global supply chain management from a single source, holding top positions in the automotive, high-tech, consumer goods and trade fair forwarding sectors, and special transports and services for major sporting events.

The Facility will have a gross floor area of approximately 54,520 square metres spread across three floors and serve as a logistics hub for DB Schenker. Earmarked to be awarded Green Mark Gold Plus, the Facility features a composite wall panel as part of the building perimeter, providing highly effective thermal insulation. A rainwater management system will contribute to enhanced water efficiency for landscape irrigation, while an efficient air-conditioning system will serve to minimise energy consumption and improve air flow distribution within the Facility. These are some components of an integrated building management system designed to create a green and sustainable environment. The Facility is expected to be completed in calendar year 2Q 2014.

Mr Thomas Chu, Managing Director of Boustead Projects said, "We are delighted to be partnering once again with DB Schenker – an established full-fledged global logistics service provider – to deliver their new logistics hub at the Tampines LogisPark. In 2006, Boustead Projects delivered the largest logistics facility located within the Airport Logistics Park of Singapore for BAX Global (now part of DB Schenker Logistics¹) and which now serves as a key facility for DB Schenker in Singapore. The new logistics hub adds to our continuous relationship with DB Schenker and builds on our excellent track record of delivering more than 785,000 square metres of logistics space regionally."

Mr Chu added, "This is the third design-and-build contract secured by Boustead Projects in the new year and is a good addition to the other five projects secured over the past three months, which include recent contracts for BASF and AIMS AMP Capital Industrial REIT, a S\$26 million contract from Airbus unit, Satair for a service repair and distribution facility at the Seletar Aerospace Park, and a S\$23 million contract from SGX-listed Oxley for Robinson Square in the Central Business District. This project brings the total value of industrial real estate contracts awarded in FY2013 to over S\$158 million."

The Facility is the second project that Boustead Projects is undertaking at the Tampines LogisPark. Boustead Projects recently completed a 34,500 square metres integrated ramp-up logistics and office facility within the Tampines LogisPark, under a S\$42 million contract secured in August 2011.

The latest contract has raised the Boustead Group's order book backlog (as at the end of September plus new orders since then) to S\$422 million.

This contract is not expected to have a material impact on the profitability, earnings per share and net asset value per share of Boustead in the current financial year ending 31 March 2013. However, it is expected to have a positive material impact on profitability and earnings per share in the following financial year ending 31 March 2014.

None of the Directors or controlling shareholders of Boustead has any interest, direct or indirect, in the above contract.
