BOUSTEAD SUBSIDIARY AWARDED DESIGN-BUILD-AND-LEASE CONTRACT FOR INTEGRATED MRO, REMANUFACTURING AND OFFICE FACILITY

- 2nd design-build-and-lease contract secured by division in FY2014
- 8th maintenance, repair and overhaul facility undertaken by division
- 13th industrial facility in industrial leasehold portfolio, raising expected portfolio size to over 152,000 square metres of gross floor area

Boustead Singapore Limited ("Boustead") is pleased to announce that its wholly-owned subsidiary, Boustead Projects Pte Ltd ("Boustead Projects") – a leading specialist in industrial real estate solutions – has been awarded a contract to design, build and lease an integrated maintenance, repair and overhaul ("MRO") and remanufacturing centre with an adjoining office building (the "Facility") that will be located at the Tukang Innovation Park ("TIP").



To be completed in calendar year 1Q 2015, the Facility will have an expected gross floor area of 24,800 square metres. The end-user client's business services, sales, after-sales and engineering functions will move into the Facility upon completion. The Facility will house a two-floor regional MRO service centre, training centre, workspaces for engine servicing, maintenance and remanufacturing of engines and also have an adjoining eight-floor corporate office building.

The Facility is Boustead Projects' third project at the TIP, an industrial park that has blossomed with its focus on innovation within industries. In 2011 and 2012, Boustead Projects completed two projects within the TIP: an integrated high-tech manufacturing

and R&D centre, as well as Greenpac's Greenhub, an integrated innovative and environmental packaging manufacturing and R&D centre which received a Solar Pioneer Award from the Economic Development Board of Singapore.

With the addition of this new facility, Boustead Projects' portfolio of industrial leasehold facilities (both completed and under construction) numbers at 13, expanding the portfolio size to an estimated gross floor area of over 152,000 square metres.

Mr Thomas Chu, Managing Director of Boustead Projects said, "We are delighted to be partnering our client to deliver their new state-of-the-art integrated MRO, remanufacturing and office facility. Riding on our excellent track record of designing and building specialised MRO facilities, we will work closely with our client to support their strategic expansion in Singapore where they have been present for many years, as well as reinforcing their commitment to their extensive network of clients and partners across Asia."

Mr Wong Yu Wei, Senior Deputy Managing Director of Boustead Projects, who has been integral in the efforts to expand the industrial leasehold portfolio, said, "We are excited with the recent acceleration of growth in the industrial leasehold portfolio. The addition of four industrial facilities totalling 50,030 square metres in gross floor area over the past three months is bringing us much closer to unlocking the value of the portfolio. Our efforts in this area are showing good results."

As the latest contract is not on a design-and-build arrangement, it will not be added to the Boustead Group's order book backlog (as at the end of June plus new orders since then), which currently stands at over S\$523 million.

This contract is not expected to have a material impact on the profitability, earnings per share or net asset value per share of the Boustead Group in the current financial year ending 31 March 2014.

None of the Directors or controlling shareholders of Boustead has any interest, direct or indirect, in the above contract.
