Boustead Projects Limited ("Boustead Projects") – a leading specialist in real estate solutions – is pleased to provide an update on its new businesses, specifically in relation to its expansion in the key overseas market of Malaysia, and in the data centre and telecommunications industries. In the last three months, Boustead Projects has been awarded contracts worth a total of S\$70 million.

In the key overseas market of Malaysia where Boustead Projects has achieved rapid expansion, Boustead Projects was awarded a design-and-build contract for an industrial facility within Iskandar Malaysia to be used by an international logistics client at the Port of Tanjung Pelepas (Flagship Zone C). Boustead Projects also secured two construction contracts for works at a petrochemical complex in Kuantan, Pahang. The award of the latest contracts in Malaysia comes shortly after Boustead Projects successfully delivered its first project in Malaysia for a global pharmaceutical corporation at the Kulim Hi-Tech Park in Kedah within 15 months.

In a separate breakthrough, Boustead Projects was awarded a design-and-build contract for a sizeable integrated data centre and office facility. The contract signifies progress in Boustead Projects' aim to move further up the value chain, with significant efforts undertaken to pursue business development opportunities in the data centre and telecommunications industries.

Mr Thomas Chu, Managing Director of Boustead Projects said, "These recent contract wins reflect the efforts we have made to secure clients in strategic niche sectors that require custom-built facilities with high technical specifications, as well as to diversify our business outside of Singapore and increase our overseas revenue. Clinching our third project in the data centre and telecommunications space demonstrates how we are gaining traction in industries higher up the value chain, where we continue to evolve our technical capabilities. In spite of the increasingly competitive landscape we operate in, the data centre contract is an endorsement of our proven track record, market-leading expertise, highly knowledgeable and skilled resource base, and ability to execute and deliver within accelerated and demanding project schedules. On the geographic expansion front, we have clearly made strong progress in Malaysia, which is our closest and most promising of overseas markets."

Mr Wong Yu Wei, Executive Director of Boustead Projects further commented on business developments in Malaysia, "Other than the latest contracts awarded in Malaysia, our first development project, iBP @ Nusajaya (Flagship Zone B) within Iskandar Malaysia is proceeding well. Together with our joint venture partners, we are clearly pleased with the sales success of Phase 1 of iBP @ Nusajaya, which has been 100% sold and comprises half of the total 100 units of our jointly-developed premier freehold business park. With construction of Phase 1 already underway, we expect completion of Phase 1 in calendar year 1Q 2017. Although the business environment in Iskandar Malaysia has been somewhat dampened since we first launched Phase 1, we are confident in a favourable end result for iBP @ Nusajaya given our secured sales, developer reputation and strength, and suitable product for the local market. The sales launch of Phase 2 is expected to take place before the end of calendar year 2016. The joint venture has also appointed Boustead Projects with the project management role for iBP @ Nusajaya."

The latest contracts secured have raised the Boustead Projects Group's order book backlog (as at the end of September 2015 plus new orders since) to S\$305 million. These contracts are not expected to have a material impact on the profitability, earnings per share and net tangible asset value per share of the Boustead Projects Group in the current financial year ending 31 March 2016.

None of the Directors or controlling shareholders of Boustead Projects has any interest, direct or indirect, in the abovementioned contracts.

Listed on the Main Board of the SGX on 30 April 2015, Boustead Projects is a 51%owned subsidiary of Boustead Singapore Limited, a progressive global infrastructurerelated engineering services and geo-spatial technology group which is separately listed on the Main Board of the SGX.
