BOUSTEAD PROJECTS AWARDED CONTRACT FOR MEDTECH FACILITY EXPANSION IN SINGAPORE

- ***Boustead Projects secures contract with business unit of global medical technology corporation***
- ***Boustead Projects further extends track record in healthcare, pharmaceuticals and medical technology industry***
- ***Boustead Projects Group's order book backlog raised to S\$620 million***

Boustead Projects Limited ("Boustead Projects") – a leading specialist in smart eco-sustainable real estate solutions – is pleased to announce that its wholly-owned design-and-build subsidiary, Boustead Projects E&C Pte Ltd ("Boustead Projects E&C") has secured a contract to design-and-build a medical technology facility expansion (the "Facility Expansion") in Singapore for a repeat client, a business unit of a global medical technology corporation.

The Facility Expansion comprises an additional gross floor area of approximately 7,500 square metres and is expected to be completed by the first quarter of calendar year 2021.

Mr Thomas Chu, Managing Director of Boustead Projects said, "We continue to build on our track record in strategic, high-value industries like the healthcare, pharmaceuticals and medical technology industry, where clients are better able to appreciate our progressive approach, market-leading technology-enabled capabilities and track record in delivering high-specification advanced projects that meet challenging stakeholder requirements. This contract adds to our healthy order book backlog. Our focus continues to be on securing opportunities in high-value industries across the region."

The latest contract has raised the Boustead Projects Group's order book backlog to approximately S\$620 million (unrecognised project revenue remaining at the end of September 2019 plus the total value of new orders secured since then).

The above contract is not expected to have a material impact on the profitability, earnings per share ("EPS") and net tangible asset value per share of the Boustead Projects Group in the current financial year ending 31 March 2020. However, it is expected to have a positive material impact on the Boustead Projects Group's profitability and EPS for the financial year ending 31 March 2021.
