

## **ACCEPTANCE OF TENDER BY JTC FOR TUKANG INNOVATION SITE**

**Singapore, 30 May 2025**

SGX Mainboard-listed Boustead Singapore Limited (SGX:F9D) ("Boustead") refers to the Press Release dated 30 May 2025 by JTC Corporation ("JTC") in relation to the public tender ("Tender") under the Industrial Government Land Sales Programme ("IGLS") for the land parcel also known as Tukang Innovation Drive Plot A (the "Site").

Boustead is pleased to announce that its Real Estate Solutions Division, Boustead Projects Limited's wholly-owned subsidiary, BP-Innovue Pte Ltd ("BP-Innovue") together with its joint venture partner (the "Joint Venture") has received a tender acceptance letter from JTC Corporation ("JTC") on 30 May 2025, awarding the Tender to the Joint Venture.

This also marks the first development project that has been secured since the recent formation in March 2025 of [vertically-integrated Pan-Asian logistics and industrial real estate platform, UIB](#), which will be jointly providing development management services to deliver this project.

The Site, launched by JTC in December 2024, is the first IGLS site to be awarded with an additional three years of lease, under recent [enhancements to the industrial land lease framework](#). The 33-year land lease tenure would allow businesses to utilise a full 30-year intended lease term. The Site spans 18,687 square metres with a proposed allowable gross floor area ("GFA") of 46,717.5 square metres. Zoned as Business 2, the land will be developed into a multi-user industrial facility with heavy vehicle parking. Strata subdivision is permitted for the development.

The development of this Site is not expected to have a material impact on the profitability, earnings per share and net tangible asset value per share of the Boustead Group in the current financial year ending 31 March 2026.

None of the Directors or controlling shareholders of the Company has any interest, direct or indirect, in the above Tender and acceptance letter.
